I.	<p>a. Approval of July 12, 2016 Minutes</p> <p>Rich requested a motion to Approve the June 7, 2016 Minutes. Motion to accept as written made by Stephan and seconded by Tom Kelly; Janine abstained. Minutes were approved as written.</p>	
2.	<p>Policies to the Board:</p> <p>The following policies going to the Board tonight for a 1st read.</p> <p>EEAA – Video and Audio Surveillance on School Property – Will need to strike the word Audio from this policy (all instances). Tom asked if the system has the ability to watermark the recording, as this would prevent altering. We need to check with the vendor. Kimberly will check the language last paragraph before 2nd read. Are these considered educational records?</p> <p>Is the gym considered a classroom? We can put recorder on a timer (for the gym). Should we document this in the policy or in the procedure? Tom is OK with this being clearly stated in the procedure. Rachel asked how this relates to teacher evaluations. EEAA is OK to move forward tonight.</p> <p>EEAB – Video and Audio Recording for Instructional and Professional Development Purposes: Tom had a question on the last paragraph. He asked about part of the RSA (legal hearing anytime we want to record) being missing from this policy. Kimberly indicated that this policy goes up as a public hearing. The revisions to the RSA indicated that this was not their intent, as it would become too burdensome. Last year we held a hearing to adopt the policy. The hearing notifies the community of what we plan to do; we would then send permissions to the families. Teachers would be a case-by-case basis.</p> <p>Do we move forward, ask legal, or include additional restrictions?</p> <p>Patrick asked if this would be mobile or a stationary thing. Kimberly explained It is not in our PD or evaluation plan to record teachers. Patrick asked who sees these video recordings and how can we ensure they are not altered? These are not used for evaluations. We would record for 1, educational purposes, or 2, for PD reasons (with the teachers' approval). There is nothing in this policy that we have used to evaluation a teacher. Patrick is concerned where the videos would go, who would have control of them, and if they would they be safe. If we were recording for PD, we would condense it and then delete it after its viewing.</p> <p>Rachel asked about the teacher and student having access to the recording. This would be an educational reason and covered under FERPA. Kimberly indicated we could create an R-procedure for this policy, covering in more detail the responsibilities of ownership. Rachel asked for examples of who might have access in student recordings. Kimberly indicated school psychologists, doctors, speech pathologists, etc.</p>	

	<p>Rich asked if anyone had specific language they wanted to add/edit. If not, he would like to move it forward for a first read. Is Kimberly contacting Legal about the hearing portion of this policy? No. Rachel asked about the Pathways III procedure. It's in the narrative of the evaluation program. Do we have cameras in our library? Motion to move for 1st read, seconded Janine. All in favor; Tom opposed. MINUTES OF THE CONTOOCOOK VALLEY SCHOOL DISTRICT

EXECUTIVE SESSION
Thursday, June 28, 1979

A special meeting of the Contoocook Valley School Board was held on the above date with Chairman Sweet, Mr. Peters, Mr. Porter, Mrs. Force, Mrs. Hubbell, Mr. Ray, Ms. von Adler, Mr. Tenney, Mr. Merrifield, Mr. Smith, Mrs. Harrington, Superintendent Page, Assistant Superintendent Carr, Business Administrator Gauthier, and Norman Makechnie, District Counsel.

With legal counsel present the Board met in executive session to determine appropriate action relative to events pertaining to an incident regarding transportation security, and to clarify the status of the transportation contract.

Mr. Page and Attorney Makechnie updated the Board and informed them of options with reference to events related to the incident of May 23, 1979, when a cover-up of a defective tire was attempted by the management of the busing company. Copies of a letter with reference to the transportation contract from Mr. Pasquala Alosa of Jan-Car, of which the Board was informed at its previous meeting, were distributed.

The Board briefly heard Mr. Douglas Brown, ConVoy bus manager, who requested to be informed of the status of the three-year contract which he signed with the District at an earlier date. He also raised the issue of discipline enforcement (aboard buses) by the administration, suggesting that a mutual understanding of policy and procedure in this area is necessary.

Following discussion of options available, the Board voted that a transportation sub-committee (Mr. Ray, Mr. Peters) and Chairman Sweet meet with Mr. Brown immediately. After hearing a report of this meeting with Mr. Brown, the Board reasserted the transportation contract as signed, and agreed that the transportation subcommittee will study the discipline issue in an effort to resolve it. The Board further requested a letter of clarification, signed by duly authorized representatives of both Jan-Car and ConVoy, stating the relationship between the two and delineating responsibility for the District's transportation contract. District counsel was instructed to prepare such a document.

Chairman Sweet read the letter of reprimand, written by him as instructed at the previous meeting, which will be sent to Mr. Alosa and Mr. Brown regarding the bus security incident. It was reaffirmed (and Mr. Brown was so informed) that the letter will be released to the media in order to inform the public of the incident.

The meeting was adjourned, with the next meeting scheduled for July 3, 1979 at 7:30 p.m.
