JLIE - Student Automobile Use

Driving a car is a privilege granted by the State of New Hampshire as long as one drives in a safe and sane manner. Careless driving around the school parking area and driveways is something more than an offense against school regulations. Careless driving is subject to police action and anyone guilty of such careless driving will be reported promptly to the police.

Improper or unsafe use of a motor vehicle on school grounds can result in suspension from school (in-school or away from out-of-school) for a period of time not exceed five (5) days. Driving a motor vehicle from school grounds during the school day without authorization will be considered improper use of a motor vehicle and will be considered grounds for discipline, up to and including suspension.

Parking at the school is a privilege granted by the school and the privilege will be withdrawn if it is abused.

Prior to driving or parking on school grounds, students will be required to register motor vehicles in the main office and will be required to have a school sticker on the motor vehicle.

If a student leaves the school grounds in a motor vehicle without authorization, parents will be notified and the student will be subject to disciplinary action including suspension from school. Students walking off school grounds are subject to disciplinary action including suspension.

Some of the major responsibilities and obligations accompanying the privilege of using private transportation include:

- a. Arriving at school in time to park the vehicle and be in the school building by the first bell.
- b. When students arrive in the morning they must park, and lock their cars and go directly to the front of the school or enter the school and go directly to the cafeteria, and remain there until the first bell rings.
- c. Operating the vehicle safely on school property and parking only in the authorized area.
- d. Not leaving school property or allowing others to leave the school grounds with the vehicle during school hours unless authorized specifically by the administration.

Student drivers are urged to use common sense and caution d Due to the pedestrian traffic in the area of the school.—S speed should not exceed 15 mph.

Cruising around in the parking lot before and after school is prohibited.

Violations of regulations will result in suspension of the right to drive on school property. and/or police prosecution.

KB – Title I Family and Community Engagement Title I Parent Involvement in Education

The School Board endorses the family and community engagement goals of the Every Student Succeeds Act and encourages regular collaboration between family members, community members, and school leadership. The education of children is viewed as a cooperative effort among the parents, school and community, other family members involved in supporting the child's development and education.

Pursuant to federal law, the District will develop jointly with distribute to parents of children participating in the Title I program a written family and community engagement policy.

The goal of this policy is to:

- (1) Honor and recognize families' funds of knowledge,
- (2) Connect family engagement to student learning,
- (3) Create welcoming, inviting cultures, and
- (4) Develop the capacity of families to negotiate the roles of supporters, advocates, and collaborators.

The District will implement at least one annual meeting that is available to all families of students attending Title I schools and/or for families that include a student who receives Title I services (Targeted Schools). These meeting will provide parents and family members opportunities to participate in the design, development, operation and evaluation of the program for the next school year. Additional meetings may be held at the will of the Superintendent or school board. These meetings will be used to:

- 1. Involve parents in the joint development of the Title I program plan, the process of reviewing the implementation of the plan, and suggesting overall school improvements goals.
- 2. Provide the coordination, technical assistance and other support necessary to assist participating schools in planning and implementing effective family and community engagement activities to improve student academic achievement and school performance.
- 3. Build the schools' and parents' capacity for strong family and community engagement.
- 4. Coordinate and integrate Title I family and community engagement strategies with those of other educational programs.
- 5. Conduct, with the involvement of families, an annual evaluation of the content of the family engagement policy and its effectiveness in improving the academic quality of the schools served. This will include identifying barriers to greater participation by parents in activities authorized by law, particularly by parents who are economically disadvantaged, have disabilities, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background. The district will use the findings of such evaluation to design strategies for more effective parental involvement and to revise, if necessary, the parental involvement policies.
- 6. Involve families in the activities of the schools served.

Title I funding, if sufficient, may be used to facilitate parent attendance at meetings through payment of transportation, childcare costs, food for the event, and academic based supplies and activities during the event. In targeted assistance programs, the families of children identified to participate in Title I programs

will receive from the school Principal and/or Title I staff an explanation of the reasons supporting each child's selection for the program, a set of objectives to be addressed, and a description of the services to be provided. Opportunities will be provided for the parents to meet with the classroom and Title I teachers to discuss their child's progress. Parents will also receive guidance as to how they can assist in the education of their children at home.



A vibrant community arts center will enhance cultural life with a high-quality performance space that does not now exist in the region; enrich education through the arts and promote 21st century skills; encourage collaboration between arts, technology, and other disciplines; and promote tourism and economic growth.

Contoocook Valley Visual and Performing Arts Center (ConVal VPAC) is a registered NH not-for-profit corporation, with federal 501(c)(3) status. We are governed by a Board of Directors and operating committees and supported by an Advisory Committee.

Recent Successes

In September, a \$20k challenge grant was awarded to ConVal VPAC by the New Hampshire Charitable Foundation's A. Erland and Hazel N. Goyette Memorial Fund. ConVal VPAC met the challenge in December, 2016. The funds will help finance architectural and financial feasibility studies.

The architectural feasibility study, completed by Hutter Construction in January, 2017, assessed site feasibility and provides preliminary cost estimates and a conceptual plan for the facility.

Eleanor Drury, of Drury Associates in Harrisville, NH, is currently conducting the financial feasibility study to determine the level of support for the project among townspeople of the ConVal school district. The results of this feasibility study will determine next steps regarding the commencement of a capital campaign.

Fundraising methods have included direct mail campaigns, online donations through the secure website, and participation in Giving Tuesday, a national, one-day, online fundraising event held in November for nonprofits.

We have developed a database of over 500 supporters.

ConVal VPAC presents special arts and culture events to enrich the community and raise funds for the project.

The *Black Fly Story Hour*, a storytelling fundraiser series first launched by ConVal VPAC in the spring of 2015, has delighted audiences with a number of sold-out performances. *Black Fly* events are scheduled twice a year, usually in fall and spring. The next *Black Fly* event will be held on October 27, 2017.

"So much attention has been given to the athletes over the years. Our playing fields have been upgraded and the gym has been renovated. It is time to give attention to those students, and community groups, that excel in the arts, music and theatre. They deserve a better place to display their talents and I believe that this is the answer."

"I think that ConVal has a fantastic arts department. We have a great theater program, but the space we're using does limit what we're able to do. The LHT is essentially a lecture hall with curtains. We don't have a full backstage, so that does affect how ambitious we can be with our set designs, because of the size restrictions. We can't fit the full band or chorus in the LHT, so we have to have our concerts in the gym, which is working for the time being, but there's a lot of loading, and unloading, and setting up and having to work around the sports schedules and that gets a little tricky. And the acoustics in there are not really what you'd prefer for a music space to sound like."



Financial Feasibility and Community Support

The Financial Feasibility Study is scheduled to be completed by the end of April, with a report to the VPAC board in May. The interim report to the VPAC board presented key findings to date:

- The feedback strongly supports the proposed performing arts center initiative as proposed and all supported the benefits of the Center to our students and local economy.
- At 50% complete: study finds strong community support for the Project but has not yet discovered the leadership giving needed.
- Remaining interviews will tell us more.


Ongoing Activities

ConVal VPAC presents special arts and culture events to enrich the community, build recognition of VPAC, and raise funds for the project. Plans in 2017 include:

- Children and the Arts: a table craft activity focused on theater and story-telling; participation in the parade.
- An Alumni Revue is planned as a fundraiser for August 2017. Efforts are underway to seek ConVal High School alumni who would like to perform musically or exhibit artworks at this event. Plans include a festive reception, a performance, and a celebration afterwards for alumni.
- Etty play VPAC will sponsor guest artist Susan Stein, playwright, actress, and educator, to perform a play based on the diaries and letters of Etty Hillesum, a holocaust victim. Plans include school performances and interactive classroom discussions, as well as a performance for the general public. October 12 14.
- The next Black Fly event will be held on October 27, 2017.
- Final results of Drury Associates' study will determine planning for a capital campaign.

Capital Campaign: Research, Design and Management

Our future strategy will be driven in part by the results of Eleanor Drury's report. Planning for this phase will begin at a VPAC board retreat in May.

Next Steps

- VPAC will continue to move forward as outlined above, and would like to establish quarterly updates to school board meetings, to ensure continuous open communications between both parties regarding the progress of the project.
- Equally important, VPAC needs to stay updated on plans to upgrade the school.
- VPAC recommends that potential candidates for principal of the high school value and support arts education, to support STEAM.
- Amend MOU to bring it into alignment with the project plan dates as outlined above.



AMENDMENT TO AGREEMENT OF JULY 9, 2015

NOW COME the Contoocook Valley Regional School District, a public	
cooperative school district, (herein "ConVal" or "District") and the Contoocook Val	ley
Visual and Performing Arts Center, a private charitable nonprofit (herein "VPAC")	
(together, "the Parties") and agree this day of, 2017 as follows:	100

Recitals

WHEREAS, the Parties entered into an Agreement on July 9, 2015, with regard to the funding and constructing a Performing Arts Center at the ConVal High School; and

WHEREAS, the District passed a Warrant Article on the March 2016 District Warrant establishing a Performing Arts Center expendable trust fund; and

WHEREAS, the Warrant Article, as passed, did not authorize the School Board to enter into any and all necessary agreements pertaining to the design, construction, operation and maintenance of a Performing Arts Center at ConVal High School; and

WHEREAS, the Parties are in agreement that additional time is needed in which to raise private donations and grants for the construction of a visual and Performing Arts Center at ConVal High School.

NOW THEREFORE, the Parties agree to amend their Agreement of July 9, 2015, as follows:

1. Notwithstanding any language in their July 9, 2015 agreement to the contrary, VPAC shall have until January 1, 2019 in which to raise the Phase II capital necessary for the construction of the visual and Performing Arts Center. In the event that the parties are in agreement that VPAC has raised sufficient capital by January 1, 2018, the District agrees to place on its 2018 Warrant an article authorizing the School Board to appropriate the funds necessary for construction from the Performing Arts Center Expendable Trust Fund and further authorizing the School Board to enter into any and all necessary agreements pertaining to the design, construction, operation and maintenance of the Performing Arts Center at ConVal High School.

In the event that, in the sole opinion of the District, insufficient funds have been raised to construct a suitable Performing Arts Center, the parties shall agree to defer placing the article on the Warrant until March 2019.

In the event that insufficient funds have been raised by January 1, 2019, the District shall determine whether it wishes to provide VPAC with additional time in which to raise funds or in the alternative to cancel the project and propose a Warrant Article permitting dissolution of the Performing Arts Center expendable trust fund and return of the funds to VPAC, as well as any other donors.

The balance of the Agreement of July 9, 2015 shall remain intact.
