Call to Order & Approval of February 5, 2019 Minutes
 Congratulations to Dr. Kimberly Saunders on achieving her Doctorate.

The meeting was called to order by Janine Lesser at 6:02 PM.

Move to approve the February 5th minutes made by Jerry Wilson and seconded by Kristen Reilly. All in favor.

2. Policies to the Board:

The following policies will be presented for a second read at tonight's Board meeting:

- a) GADA: Employment References and Verification (Prohibiting Aiding and Abetting of Sexual Abuse)
- b) JJJ: Access to Public School Programs by Nonpublic, Charter School, and Home Educated Pupils

3. Policies for Discussion

New Policies for Discussion:

a) CFA: Individual School Administrative Personnel; also included is the NHSBA procedure. Dr. Saunders indicated the School Board should be hiring only teachers and the Superintendent. If the Board hires anyone else, they are giving the new hires rights that they do not have under the law and makes it difficult for the Superintendent to terminate employment. For example Dr. Saunders should be signing Dr. Forrest's contract. NHSBA indicated this is already policy so it did not have to be made law. Dr. Saunders can have our legal counsel look at this if this committee wishes. We will keep this policy on the agenda for further discussion. This would apply to principals and paras but would not apply to teachers. Rich Cahoon feels we have an issue with getting the legislature's ear and he's not sure he wants to. He feels someone erred and this is the reaction.

ACTION: Dr. Saunders will bring this to Legal for review and we will hold this for further discussion after a legal review.

Existing Polices That Require Updating: includes NHSBA updated policies

a) ADB/GBEC: Drug-Free Workplace/Drug-Free Schools (also applies to identical policy ADB, included)

NHSBA updated in Sept. 2018. How seriously do we want to take the NHSBA version? The committee agrees that the NHSBA version is better than our existing policy.

Do we post on the busses? The "Drug-free" distance around a school is 1000 ft. This NHSBA policy also defines the workplace. Vaping is included in this.

ACTION: Dr. Saunders will bring this to Legal for review and we will hold this for further discussion after a legal review.

b) ADC/GBED/JICG: Tobacco Products Ban Use and Possession In and On School Facilities and Grounds.

NHSBA defines the different tobacco products; ours is not as extensive. We can add information on field trips under the section of Students. This applies to all students, regardless of their age. Rich Cahoon indicated their implementation section is not in our policy. Kristen Reilly inquired about parents who help out on long field trips, like DC. Are they told at

We will move forward with this NHSBA version.

a parent meeting that they cannot smoke and drink?
