1. Call to Order

Niki McGettigan called the meeting to order at 6:18 p.m.

2. Accept Minutes of November 12, 2020

Jim Fredrickson moved to accept the minutes of November 12, 2021. Kevin Pobst second. Niki McGettigan abstained. All others in favor. Motion carried.

3. Review Website Updates from School Board

Niki McGettigan thanked Jim Fredrickson and Tim Theberge for getting information out and on the website.

Jim Fredrickson asked for information about the CVEA Contract so information could be written. Jim asked that when Guilfoil sends out a Press Release that the Communication Committee could be copied. Kimberly Saunders confirmed.

Janine Lesser asked if Guilfoil could be asked to write another release promoting the contract. Confirmed.

Kimberly Saunders invited Communication Committee members to next Thursday's meeting with Guilfoil.

5. Discuss future assignments regarding budget, District Meeting, Remote Learning etc.

Jim Fredrickson spoke about the need to sell the budget between the proposed and the default. We get there with preschool and K-8 Remote.

Kevin Pobst asked why we need to spend on a remote school when we had one this year? Continue writing the preschool piece? We added one year staff; let's write about it?

Kevin Pobst said that it would be helpful if there were a quote from Jerry Wilson on the release for the CVEA Contract in order to promote it.
